Subject: Clarification of operating results different from the same period last year more than 20% (additional)

Rich Asia Corporation Public Company Limited and subsidiaries would like to clarify the results of the quarter ended March 31, 2017 according to the regulation of The Stock Exchange of Thailand as follows

1. Total sale revenue and service was 203.38 million Baht, decreased 580.51 million Baht or 74.06% from the same period last year due to the Company and its subsidiary received orders from customers in this period decreasing from the same period last year.

Other Revenue was 4.71 million Baht, decreased 0.62 million Baht or 15.11% from the same period last year due to other service revenues decreased.

- 2. Cost of goods sold and service was 204.97 million Baht, decreased 511.93 million Baht or 71.41% from the same period last year due to the sales volume and sales revenue has decreased.
- 3. Selling, administrative and others expenses was 23.35 million Baht, increased 1.01 million Baht or 4.53% from the same period last year due to the increased of machine repairing expense and legal & other consulting fees.

In addition, the company has recognized doubtful account increased amount of 241.80million Baht from the same period last year which is estimated from unpaid debtor. Such estimation are based on the Company's regulations related accounting policy. Details of debtors with estimated additional doubtful account according to letter No. 028/2560, dated March 14, 2016 are as follows:

Company debtors

The Company has estimated additional doubtful account for this period totaling 212.27 million Baht, which are debtors the Company has already partially estimated in 2016. Whereby, these additional debtors are overdue accounts receivable and in request for payment extension process, thus the additional debt overdue exceeded 181-365 days.

Furthermore, there is reversal of doubtful accounts on receiving repayment from debtor amount of 2.21million Baht.
