Jasmine Telecom Systems Public Company Limited (the "Company") would like to submit a copy of its consolidated statement of financial position and comprehensive income for the second quarter of the year 2017, ended June 30, 2017, reviewed by the Company's external auditor, and by the Audit Committee at the Meeting No. 4/2017 convened on August 10, 2017 and approved by the Board of Directors at the Meeting No. 4/2017 convened on August 10, 2017, respectively.

Also, on this occasion, the Company would like to report its operating results as detailed below.

1. Total Revenue

The total revenue of the Company and its subsidiary for the second quarter of the year 2017 was Baht 28.65 million, decreasing by Baht 1.19 million or 3.99% when compared to that of Baht 29.84 million in the second quarter of the year 2016. The total revenue comprised:-

- The revenue obtained from Telecom Systems Integration business of Baht 2.41 million;
- The revenue obtained from Computer Systems Integration business and Cloud Computing business of Baht 21.84 million;
- Other revenue of Baht 4.40 million.

2. Cost of Sales and Services, Selling and Servicing Expenses and Administrative Expenses

The cost of sales and services, the selling and servicing expenses and the administrative expenses of the Company and its subsidiary for the second quarter of the year 2017 was Baht 22.97 million, decreasing by Baht 10.70 million or 31.78 % when compared to that of Baht 33.67 million in the second quarter of the year 2016.

3. Operating Profit

The operating profit of the Company and its subsidiary for the second quarter of the year 2017 was Baht 5.46 million, increasing by Baht 11.73 million or 187.08 % when compared to the operating loss of Baht 6.27 million in the second quarter of the year 2016.

4. Net Profit (Loss)

The operating profit of the Company and its subsidiary for the second quarter of the year 2017 was Baht 5.46 million; this amount included by exchange gain of Baht 0.36 million resulted in the record of net profit of the Company and its subsidiary for the second quarter of the year 2017 of Baht 5.82 million, increasing by Baht 12.04 million or 193.57% when compared to the net loss of Baht 6.22 million in the second quarter of the year 2016.
