Six-month period operating income of Matichon Public Co., Ltd and its affiliated companies which ended June 30, 2017 was \$\Beta\$ 449.98 million, downed \$\Beta\$ 4.29 million from the same period last year or 0.94 % while costs of sales and services was \$\Beta\$ 319.91 million, \$\Beta\$ 34.68 million decreasing or 9.78 %.
