Subject: Report on the 2nd Quarter Performance

The company would like to report on the 2nd Quarter Performance (“Q2/17”) as follows:

1. Revenues from sales and service in Q2/17 amounted Baht 54.27 million compared with Baht 69.01 million of the same period last year which decreased by Baht 14.74 million (decreased 21.36%) because of lower sales volume.
2. Cost of sales and service Q2/17 amounted Baht 41.55 million (76.56% of Revenues from sales and service) compared with Baht 52.46 million of the same period last year or 76.02% decreased by Baht 10.91 million or 20.80% because of lower sales volume.
3. Operation result in Q2/17.

Company loss from operation amount Baht 1.78 million, but gained from sale of securities amount Baht 1.16 million and unrealized gain on marketable trading securities of Baht 0.39 million compared with the same period last year company gained on sale of securities of Baht 1.71 million and had unrealized gain from marketable trading securities of Baht 2.49 million. As a result in Q2/17 company had net profit of Baht 3.91 million compared with the same period of last year company had net profit of Baht 5.48 million.
