In Q3/2017, the Company recorded revenues from sales and services of Baht 344.69 million, increasing by Baht 166.07 million or 92.97% from the same previous period of Baht 178.62 million. Due to the full revenue recognition from the business obtained from Chilmatch Co.,Ltd. and its subsidiary. Another reason is the increasing revenue of the Air-conditioning and sanitary products division.

Net profit of Q3/2017, Baht 33.90 million increased Baht 21.11 million or 165.05% in the same period of 2016, Baht 12.79 million.

Period Q3/2017, more expenses are increased, the selling expenses increased Baht 13.92 million and the administrative expenses increased Baht 15.57 million. The main reasons of increase are expenses for new business units: the refrigeration systems and the digital printing systems that the Company had received from the entire business transfer.
