"HHC" - a subsidiary of FVC, and Wuttisak Clinic Inter Group Co., Ltd. "WCIG"- an indirect subsidiary of E FOR L Aim Public Co., Ltd. "EFORL", of which details appeared on the above-mentioned letters; and any further progress shall be informed to SET appropriately.

From the aforesaid signings, HHC shall be entitled to operate "Wuttisak Clinic in the Zones as follows, totaling to 25 Branches. Franchise period of each branch when HHC commenced the operation is 12 years (Agreement period 8 years and Automatic renewal 4 years as from the date HHC exercise Franchise by developing such branch, which HHC shall be entitled to decide for branch within 10 years)


