## **Net Profit**

The company and subsidiaries realized net loss of Year 2017 ended as of December 31, 2017 of THB 72.28 million, decreased by THB 114.98 million or 269.26% comparing to the Year 2016 ended as of December 31, 2016 which the realized net profit for THB 42.70 million, for the following reasons;

## Revenue

The company and subsidiaries realized the revenue as of December 31, 2017 of THB 2,461.06 million which decreased by THB 1,028.92 million or 29.48% from the Year 2016 ended as of December 31, 2016, which realized the revenue THB 3,489.97 million, where the reasons are summarized as follows.

### 1. Revenue from Sales

- 1.1 Revenues from sales of biodiesel business to total revenue for the Year of 2017 and 2016 were 78.43% and 75.99% respectively, which was effected by two factors;
  - Raw material price: the average price product from Crude Palm Oil (CPO) in Year of 2017 was THB 28.04 / kg., which lower than Year of 2016 of THB 36.08 / kg. since the price of crude palm oil within the country very fluctuated and increased due to the palm fruits crop over released to the market. These leads to a decrease in the crude palm oil price since 1<sup>st</sup> quarter of 2017 and to the lowest at THB 18.00 / kg. in 4<sup>th</sup> quarters.
  - Quantity: Sale volume in the Year of 2017 was 68,791 tons, which has decreased by 4,721 tons or 27.22% a result from decrease purchased order from existing customer. Even though, there has been an increased Biodiesel blend in Diesel from 5% to 7% on May 8, 2017 since CPO became over supply. In 3<sup>rd</sup> and 4<sup>th</sup> quarters of 2017 received more purchased order as expected from the mandate change.
- 1.2 Revenues from sales of by-products to total revenue for the year of 2017 and 2016 were 4.70% and 1.53% respectively. The revenue from by-products in the year of 2017 has increased from the year of 2016 by THB 62.32 million or 11.68 %. Sales volume of Crude Glycerin has been increased due to an increase in Biodiesel's production and sale and the Crude Glycerin price.
- 1.3 Revenues from Edible Oil in 2017 have decreased from 2016 by 81.60% since the Company has changed its Edible Oil Sales policy into Edible Oil refining service in the beginning of 2017.

## 2. Refining Service

Revenues from Refining Service to total revenue for the year of 2017 and 2016 were 3.13% and 0.93% respectively.

- 2.1 The revenue from RBD Palm Oil Refining Service for Biodiesel in the year of 2017 is THB 39.16 million and 2016 for THB 32.58 million which has increased 7,312 tons of CPO or 20.20%
- 2.2 The revenue from Refining Service for Edible Oil in the year of 2017 is THB 37.87 million or 23,340 tons of CPO since January 2017.

## 3. Sea Freight Carrier Business

Revenue from Sea Freight Services in 2017 is THB 32.92 million, which more than revenue received in 2016 for THB 29.94 million. Currently, AIL put its vessel on the market for sale.

## 4. Gain from Disposed Non-Current Asset and Other Income

The Company and the Subsidiaries had Revenue from Other Income in the year of 2017 for THB 4.86 million, which were from service, interest received, and gain from foreign exchange. Also, AIPT gain from disposal of AIPT's assets and equipments for THB 156.57 million.

## **Cost of Sales and Services**

The company and subsidiaries realized the cost of sales and services as of 2017 of THB 2,399.58 million and the ratio of cost of sales over total revenue was 97.50%, and as of 2016 of THB 3,323.36 million and the ratio of cost of sale over total revenue was 95.23%, which decreased by 26.47%, where the reasons are summarized as follows.

### 1. Cost of Sales

- 1.1 The cost of Sales-Biodiesel to total revenue as of 2017 is 107.34% increased by 16.11% from 2016 of 94.23%, which was effected by the realized cost CPO used in production, was higher than the Company's product selling price approximately THB 1.00 2.00 / kg. Even though, the Company has achieved to obtain the improved production yield and managed to have a quicker turnover of raw material and keep minimum stock less than 30 days.
- 1.2 The cost of By-products Sales was depending on market price at the time of sales and the cost will contribute to the cost of main product's production.

### 2. Cost of Refining Service

In 2017, the ratio of cost of service to revenue was 81.77%, increasing 2016 of 82.42 % as follows;

- 2.1 The refining service for RBD Palm oil for Biodiesel has the ratio of cost of refining service to revenue in 2017 was 75.28%. The Company is continuously making profit from refining service of RBD palm oil for B100.
- 2.2 The refining service for Edible Oil refining and packaged under brand PAMOLA, according to the Company's policy to cancel its Sale of Edible Oil department and operated as Edible Oil refining service instead because the Edible Oil market if highly competitive and the Edible Oil refining service might reduce the risk of CPO's price volatility, where the refining services price were established by using a comparable approach based on the market price in the Palm Oil refinery industry. In 2017, the refining service of Edible Oil has the ratio of cost of refining service to revenue of 88.48%.

Cost of Sea Freight Service

AIL has cost of sea freight service as of 2017 at THB 40.77 million with the ratio of cost of sea freight

service to revenue at 123.85%.

**Selling Expenses** 

The company's selling expenses as of 2017 was THB 11.95 million, which decreased from selling

expenses the amount of THB 32.32 million in 2016 because the cancelation of Edible Oil Sale department. The

selling expenses are including transportation costs for Biodiesel and Glycerin's export expenses.

**Administration Expenses** 

The company's administration expenses as of 2017 was THB 90.95 million which increased by THB 9.31

million or by 11.40% from administration expenses the amount of THB 81.64 million in 2016. As results from the

loss from the disposal of the Company's unused trucks and trailers of THB 3.85 million, expenses occurred during

its subsidiaries selling their assets of THB 3.84 million, and realized of allowance for impairment of investments in

subsidiary for THB 24.00 million.

Financial Cost

The financial cost as of 2017 was THB 1.72 million, which decreased by THB 6.29 million or 78.47%

from financial cost the amount of THB 8.01 million in 2016 due to loan repayment.
