The operating results of the consolidated financial statement for the first quarter period ended March 31, 2018 resulted in increase in net profit of Baht 70.65 million or 349.03% from the corresponding period of the previous year as the following details below:

- 1. Revenue from sales and services increased Baht 924.08 million or 259.78% from the corresponding period of the previous year, which resulted in the increase in revenue from UAC at the amount of Baht 922.56 million, gross profit increased Baht 79.48 million or 115.13% from the corresponding period of the previous year.
- 2. Comprehensive Income increased Baht 70.65 million or 349.03% from the corresponding period of the previous year resulting from the details below;
 - Increase in gross profit at Baht 79.48 million.
 - Increase in other income at Baht 12.10 million from profit sharing from investment in BBF.
 - Increase in income tax at Baht 17.83 million.

The operating results of the separated financial statement for the first quarter period ended March 31, 2018 resulted in increase in net profit of Baht 14.34 million or 27.27% from the corresponding period of the previous year as the following details below:

- Revenue from sales and services increased Baht 922.56 million or 359.20% from the corresponding period of the
 previous year, which resulted in the increase in revenue from UAC Trading. This quarter, UAC gained
 revenue from sale of product at the amount of Baht 843.54 million which was not a regular transaction.
 Consequently, gross profit increased Baht 84.42 million or 198.18% from the corresponding period of the
 previous year.
- 2. Other Income decreased at the amount of Baht 48.25 million or 84.82% from the corresponding period of the previous year, due to no dividend payment from BBF in this quarter.
- 3. Comprehensive Income increased Baht 14.34 million or 27.27% from the corresponding period of the previous year, due to the increase in gross profit of Baht 84.42 million, decrease of Other Income of Bath 48.25 million and Increase of Income Tax of Bath 20.10 million.
