Subject : Report on the Company's operating results of the second quarter of the year 2018
To : President of the Stock Exchange of Thailand

The Board of Directors' Meeting No. 5/2018 of Jasmine Telecom Systems Public Company Limited (the "**Company**") held on August 10, 2018, has resolved to approve the consolidated financial statements for the second quarter of the year 2018, ended June 30, 2018, that have been accordingly reviewed by the Company's external auditor and by the Audit Committee at the meeting No. 3/2018 held on August 10, 2018. Also, on this occasion, the Company would like to report its operating results as detailed below:-

1. Total Revenue

The total revenue of the Company and its subsidiary for the second quarter of the year 2018 was Baht 26.27 million, decreasing by Baht 2.38 million or 8.31 % when compared to that of Baht 28.65 million in the second quarter of the year 2017. The total revenue comprised:-

- The revenue obtained from Telecom Systems Integration and Telecom Service business of Baht 8.78 million;
- The revenue obtained from Computer Systems Integration business and Cloud Computing business of Baht 15.18 million;
- Other revenue of Baht 2.31 million.

2. Cost of Sales and Services and Administrative Expenses

The cost of sales and services and the administrative expenses of the Company and its subsidiary for the second quarter of the year 2018 was Baht 23.39 million, increasing by Baht 0.42 million or 1.83% when compared to that of Baht 22.97 million in the second quarter of the year 2017.

3. Operating Profit

The operating profit of the Company and its subsidiary for the second quarter of the year 2018 was Baht 1.66 million, decreasing by Baht 3.80 million or 69.60% when compared to that of Baht 5.46 million in the second quarter of the year 2017.

4. Net Profit

The operating profit of the Company and its subsidiary for the second quarter of the year 2018 was Baht 1.66 million; this amount included by the exchange loss of Baht 1.49 million, resulted in the record of the net profit of the Company and its subsidiary for the second quarter of the year 2018 of Baht 0.17 million, decreasing by Baht 5.65 million or 97.08% when compared to the net profit of Baht 5.82 million in the second quarter of the year 2017.
