**Subject: Report on the 2<sup>nd</sup> Quarter Performance of year 2018**

The company would like to report on the 2<sup>nd</sup> Quarter Performance (“Q2/18”) as follows:

1. Revenues from sales and service in Q2/18 amounted Baht 77.84 million compared with Baht 54.27 million of the same period last year which increased by Baht 23.57 million (increased 43.43%) because of higher sales volume.
2. Cost of sales and service in Q2/18 amounted Baht 57.28 million (73.59% of Revenues from sales and service) compared with Baht 41.55 million of the same period last year (76.56% of Revenues from sales and service) or decreased by 2.97% because company could manage cost efficiently and reduced loss from operation.
3. Operation result in Q2/18.

Company had profit from operation amounted Baht 4.01 million, loss from sale of securities amounted Baht 0.64 million and also had unrealized loss on marketable trading securities of Baht 1.26 million compared with the same period last year company gained on sale of securities of Baht 1.16 million and had unrealized gain from marketable trading securities of Baht 0.39 million.

As a result in Q2/18 company had net profit of Baht 1.70 million compared with the same period last year company had net profit of Baht 3.90 million.
