3. General Characteristics of the transaction

Company wishes to buy the estate from Mrs. Araya Kongsoonthorn and Mr. Chudet Kongsoonthorn the title deed no. 164087 land no. 5612 Surasak sub-district, Sriracha district, Chonburi province of the amount 42 square meters with the building in total amount of 8,050,000 Baht (Eight million and fifty thousand baht)

The assessors use the market valuation Approaches to Asset Characteristics Asset Valuation (Both Land and Building) by compare to the market value with the same asset in the same area and use the value of the market price. That concern with market condition.

4. Total value and criteria used to determine the total value of the transaction

4.1 Total value of pay-off: The amount of 8,050,000 baht is considered as an acquisition of assets. According to the Board of the Stock Exchange of Thailand Disclosure of Information and Other Acts of Listed Companies Concerning the Acquisition and Disposition of Assets, 2004. By the transaction size is 0.6% of the total assets of the company. In the consolidated financial statements end in June 30, 2018. Which the transaction size is less than 15% of the total assets of the company and the transaction is considered as connected transaction. The total value of this transaction is 8,050,000 Baht. Which the transaction value is more than 1 million Baht but less than 20 million Baht or the value is more than 0.03% but less than 3% of the net assets, Which the transaction as mention must have authorized from board of the company and publish to the Stock Exchange of Thailand. This is in accordance with the Notification of the Board of the Stock Exchange of Thailand. Disclosure of Information and Other Acts of Listed Companies Concerning the Connected Transactions since 2003.

The Company has ratified the resolution to purchase land and buildings as mention above from Mrs. Araya Kongsoonthorn and Mr. Chudet Kongsoonthorn can bring the use of land and building to benefits for Office building as Laemchabang Branch due to it's in the area of Laemchabang port, Laemchabange Industrial Estate and Pinthong Industrial Estate because it is necessary for the company. Must buy the purchase price of land and buildings from connected persons in a fair price reason by appraised value of the assets.
