The Board of Directors approved the company to enter into the transaction to sell partial ordinary shares in President Bakery Plc., for the number of 1,500,000 shares, at Baht 61.16 per share, for total amount of Baht 91,740,000.-, to Thai President Foods Plc. who is a connected party to the company. Said transaction was intended to reduce its investment proportion in non-core business, as well as to receive capital gain on the sale of shares, based on relevant favourable prices and conditions. Whereas the company still holds the remaining 3,000,000 ordinary shares in President Bakery Plc. because President Bakery Plc. has good performance and the company receives return benefits in terms of dividend income.
