Subject: Management Discussion and Analysis of Q3/2018

M.C.S. Steel Public Company Limited would like to clarify the operating result for the consolidated financial statements of company and subsidiary of Quarter 3/2018 periods ended 30 September 2018 that reviewed by the Independent Auditor , details are as followings ;

- 1. In Q3/2018, the company's Profit was 43.598 Million Baht , a decrease of 110.24 Million Baht or 71.66% from same period of last year. (The profit in the separate financial statements was 41.071 Million Baht).
- 2. In Q3/2018, the company's gross profit in the separate financial statements was 188.427 Million Baht, a decrease of 150.549 Million Baht or 44.41% from same period of last year. if included the gross profit from subsidiary companies it will be 219.60 Million Baht, a decrease of 122.626 Million Baht or 35.83% from same period of last year.
- 3. In Q3/2018, the company's sale revenue was 1,018.399 Million Baht, a increase 125.421 Million Baht or 14.05% from same period of last year which was the sale revenue in the separate financial statements 947.549 Million Baht, a increase of 83.024 Million Baht or 9.63%.

Management Discussion and Analysis of 03/2018

- 1) In Q3/2018, the export work which included subsidiary company in China were around 11,471 Tons and domestic work was around 2,158 Tons. As a result, the sales revenue increased 83.024 Million Baht or 9.63%.
 - If included the sale revenue from subsidiary companies, it will be 1,018.399 Million Baht ,a increase of 125.421 Million Baht.
- 2) In Q3/2018, Cost for sales of goods from MCS (Thai) increased by 233.753 Million Baht or 44.49% which was due to increased export work in Q3/2018 and the company has booked a potential lost for domestic project (AOT) in Q4/2018 around 35.285 Million Baht.
 - And if included the subsidiary companies ,cost for sales of goods was 798.799 Million Baht ,a increase of 248.047 Million Baht or 45.04%.
- 3) In Q3/2018, the Selling expenses increased by 4.159 Million Baht which was due to increased the export work.

The Administrative expenses decreased by 2.305 Million Baht.

- 4) At 30 September 2018, Inventories was 899.861 Million Baht ,a increased by 94.158 Million Baht from 31 December 2017 which was the work in process that was waiting to delivery in Q4/2018.
- 5) At 30 September 2018, Property, plant and equipment decreased by 68.672 Million Baht from 31 December 2017 due to the depreciation.
- 6) In Q3/2018, Finance costs decreased by 0.725 Million Baht.

As stated as above No.1 - 3, In Q3/2018, the. company's profit in Consolidated financial statements was 43.598 Million Baht.
