For the 3 months period (quarter 2/2019), the Company has total revenues at Baht 135.78 million which increased compared to the same quarter of prior year by Baht 14.02 million or equivalent to 10.33% and For the 6 months period of 2019, the Company has total revenues at Baht 259.81 million which increased compared to the same quarter of prior year by Baht 31.77 million or equivalent to 12.23%, resulting gross profit at Baht 20.57 million but the Company has total comprehensive loss at Baht 10.26 million. However, the loss decreased compared to the same quarter of prior year 49.55%

For the 3 months and 6 months period (quarter 2/2019), the Company has revenues from dental services at Baht 125.90 million and at Baht 242.44 million, which increased compared to the same quarter of prior year by Baht 10.56 million and Baht 26.46 million or equivalent to 9.16% and 12.25%. Revenues from dental services can be classified according the operation areas as follows:

- Bangkok and vicinity generated revenues from dental services at Baht 103.90 million and Baht 200.65 million which increased compared to the same quarter of prior year by Baht 6.78 million and Baht 18.23 million or equivalent to 6.98% and 9.99%.
- Other provinces generated revenues from dental services at Baht 22.00 million and Baht 41.79 million which increased compared to the same quarter of prior year by Baht 6.78 million and Baht 8.23 million or equivalent to 20.78% and 24.52%.

For the 3 months and 6 months period (quarter 2/2019), the Company has cost of services at Baht 120.99 million and Baht 235.23 million which increased compared to the same quarter of prior year by Baht 13.01 million and Baht 27.67 million or equivalent to 12.05% and 13.33% mainly due to increasing dentist remuneration, employees' salaries of the office and branches, medical supplies and other supplies, laboratory expense, utilities and tourism cost by Baht 4.33 million and Baht 7.51 million, respectively.

For the 3 months and 6 months period (quarter 2/2019), the Company has distribution cost at Baht 5.88 million and Baht 1 1.0 3 million which increased and decreased compared to same quarter of prior year by Baht 0.20 million and Baht 1.22 million or equivalent to 3.46% and 9.93% mainly due to decreasing of advertising and promotion expenses – CLMV (because the project was canceled) and increasing of sales incentive by Baht 0.22 million and Baht 0.71 million.

For the 3 months and 6 months period (quarter 2/2019), the Company has administrative expenses at Baht 11.82 million and Baht 23.98 million which decreased compared to same quarter of prior year by Baht 1.27 million and Baht 2.38 million or equivalent to 9.68% and 9.03% mainly due to decreasing of tourism expense Baht 2.02 million and Baht 3.56 million (because in this year the tourism expense is presented under cost of services) and decreasing of consultant fee Baht 0.64 million and Baht 2.65 million.

Current assets at Baht 102.61 million, decreased by Baht 8.83 million or equivalent to 7.93%, mainly due to decreasing of cash and cash equivalent by Baht 20.14 million or equivalent to 31.50% (because it was used in the operation).

Account receivable and other receivable at Baht 15.38 million, increased by Baht 8.37 million or equivalent to 119.43%, mainly because of advance payment for the rental – Changwattana branch in amount of Baht 2.80 million and accrued income - tour in amount of Baht 4.20 million.

Land, building and equipment at Baht 1 4 8 . 9 7 million, decreased by Baht 0 . 9 9 million or equivalent to 0.66% because of the depreciation.

Assets on long-term lease at Baht 94.83 million, decreased by Baht 4.34 million or equivalent to 4.38% mainly because of write-off the asset impairment.

#### 2.2 Liability analysis

As at June 30, 2019, the Company has total liabilities at Baht 92.87 million which decreased from as at December 31, 2018 by Baht 5.94 million or equivalent to 6.01%.

Liabilities under financial lease at Baht 5.58 million, decreased by Baht 6.94 million or equivalent to 55.43% because the installations made according to the financial lease contract and no additional contract.

Non-current provisions for employee benefits at Baht 5.32 million, increased by Baht 0.88 million or equivalent to 19.84% because of new calculation based on 400 days benefit in case of retirement according to the Labour Protection Act in the quarter that it was applied.

# 2.3 Shareholders' Equity Analysis

As at June 30, 2019, Shareholders' equity at Baht 270.71 million, decreased by Baht 10.26 million or equivalent to 3.65% resulting from operation loss.
