JCK Hospitality Public Company Limited ("Company") would like to report the consolidated operating performance results for the 2<sup>nd</sup> quarter of 2019 as follows;

- For the 2<sup>nd</sup> quarter of 2019, the Company's total revenue was Baht 322.41 million, decreased by Baht 77.88 million or 19.46% from the same quarter of 2018, due to intensified market competition on restaurant business.
- The Company's cost of goods sold in the 2<sup>nd</sup> quarter of 2019 was Baht 157.76 million, decreased by Baht 27.31 million, or 14.75% from the same quarter of 2018, as a result of decreasing in sales.
- 3. The Company's selling and administrative expenses in the 2<sup>nd</sup> quarter of 2019 were Baht 220.51 million, increased from the same quarter of 2018 by Baht 5.55 million, or 2.58%
  For the administrative expenses in the 2<sup>nd</sup> quarter of 2019 amounting to Baht 38.80 million, increased from the same quarter of year 2018 by Baht 17.81 million equivalent to 85%, was caused from accounting adjustment by reversing impairment expenses from the closure of some branches.
- The Company's financial cost in the 2<sup>nd</sup> quarter of 2019 was Baht 2.85 million, increased from the same quarter of 2018 by Baht 6.97 million, or 32.37% due to payment of loan interest to financial institutions.
- The Company had net loss of Baht 61.65 million, increased from the same quarter of 2018 by Baht 54.55 million, or 768.51% due to reduction of sales.
