Whereas the Meeting No. 4/2562 of the Board of Directors of DCON Products Public Company Limited has resolved on 14 November 2019 to adopt the financial statement for the 3rd. quarter of 2019 ended 30 September 2019, the Company wishes to submit herewith explanation and analysis of the Management as follows.

In the 3rd. Quarter of 2019 the Company and subsidiaries had a total income of 318.98 million Baht, decreasing by 62.43 million Baht, or 16 per cent, from the 3rd. quarter of 2018, with 33.17 million Baht coming from construction materials business while decreasing from real estate business 29.26 million Baht cause of the decreasing in sales Condominium in this Quarter.

In this Quarter the real estate segment is very stagnant .The Company not only try to reduce all cost and expenses but although try to develop and maintain best quality. So, in this quarter The Company can make the gross profit of construction materials business 34.4 % which higher than the same period of the last year which is 32.4%

From the above reason, the operation in 3rd. quarter of 2019, the company and subsidiaries company have net profit after tax amounting 39.28 million Baht decrease from the same period of the last year which have the net profit amounting 53.42 million or decrease 26%
