For the 3 months period (quarter 3/2019), the Company has total revenues at Baht 146.68 million which increased compared to the same quarter of prior year by Baht 20.83 million or equivalent to 16.55% resulting gross profit at Baht 17.72 million, net profit at 0.03 million and For the 9 months period of 2019, the Company has total revenues at Baht 406.49 million which increased compared to the same quarter of prior year by Baht 52.60 million or equivalent to 14.86%, resulting gross profit at Baht 38.29 million but the Company has total comprehensive loss at Baht 10.23 million. However, the loss decreased compared to the same quarter of prior year 62.79%

For the 3 months and 9 months period (quarter 3/2019), the Company has revenues from dental services at Baht 135.91 million and at Baht 378.35 million, which increased compared to the same quarter of prior year by Baht 16.43 million and Baht 42.88 million or equivalent to 13.75% and 12.78%. Revenues from dental services can be classified according the operation areas as follows:

- Bangkok and vicinity generated revenues from dental services at Baht 112.69 million and Baht 313.35 million which increased compared to the same quarter of prior year by Baht 12.57 million and Baht 30.79 million or equivalent to 12.55% and 10.90%.
- Other provinces generated revenues from dental services at Baht 23.22 million and Baht 65.01 million which increased compared to the same quarter of prior year by Baht 3.86 million and Baht 12.09 million or equivalent to 19.95% and 22.85%.

For the 3 months and 9 months period (quarter 3/2019), the Company has cost of services at Baht 127.16 million and Baht 362.39 million which increased compared to the same quarter of prior year by Baht 15.09 million and Baht 42.76 million or equivalent to 13.47% and 13.38% mainly due to increasing dentist remuneration, employees' salaries of the office and branches, medical supplies and other supplies, laboratory expense, utilities and tourism cost by Baht 6.19 million and Baht 13.70 million, respectively.

Current assets at Baht 107.84 million, decreased by Baht 3.60 million or equivalent to 3.23%, mainly due to decreasing of cash and cash equivalent by Baht 14.97 million or equivalent to 23.42% (because it was used in the operation).

Account receivable and other receivable at Baht 13.55 million, increased by Baht 6.54 million or equivalent to 93.28%, mainly because of advance payment for the rental – Changwattana branch in amount of Baht 1.96 million and accrued income – tour in amount of Baht 5.43 million.

Land, building and equipment at Baht 1 4 9.27 million, decreased by Baht 0 .69 million or equivalent to 0.46% because of the depreciation.

Assets on long-term lease at Baht 89.44 million, decreased by Baht 9.73 million or equivalent to 9.82% mainly because of write-off the asset impairment.

2.2 Liability analysis

As at September 30, 2019, the Company has total liabilities at Baht 93.25 million which decreased from as at December 31, 2018 by Baht 5.56 million or equivalent to 5.63%.
