Revenue from sales and services

The Company's sales and services revenue for 1st Quarter 2020 is increased by THB 16.84 million or equivalent to 16.63 percent, due to deceasing in Sales revenue by THB 12.65 million or equivalent to 14.00 percent which resulted from increasing in competitor and effect from Coronavirus Disease19. In addition, revenue from contract works and revenue from rental incomes is increased by THB 27.63 million and THB 2.23 million respectively or equivalent to 297.10% and 314.08% respectively due to installation solar cell project 1 MW and warehouse tenants increased.

Gross Profit / Margin

The Company's gross profit for 1st Quarter 2020 is THB 26.42 million is increased by THB 0.88 million from the same period of last year.

Net Profit / Margin

The Company's net profit 1st Quarter 2020 is THB 12.85 million equivalent to 10.88 percent, in which the net profit margin of the Company has increased when compared to the same period of last year due to the decreasing of allowance for doubtful debt is THB 6.10 million and decreasing in sales and administrative expenses because The Company has tightened spending.
