Base on calculation of maximum value. The acquisition equivalent to 0.43% of the value of net tangible assets which is a maximum transaction value calculated from the reviewed consolidated financial statements as of 31 March 2020. The Company has not entered any acquisition of investment during the past 6 months with values less than 15%. Therefore, the Company is not required to perform any disclosure under the obligation of such Notification.

Trading transaction in level 1 is not within the scope of connected transaction under the Notification of the Capital Market Supervisory Board No. Tor Chor 21/2551 Subject: Rules on Connected Transaction and the Notification of the Board of Governors of the Stock Exchange of Thailand B.E.2546 since it is excecution of the transaction with the person/legal entity which is not the Company's connected person. Moreover, the trading transaction in level 2 and level 3 with the total value of transaction is amount 3,133,125 baht, the transaction is considered as connected party transaction as prescribed the Notification of the Board of Governors of the Securities Exchange of Thailand Re: Disclosure of Information and Other Acts of Listed Companies Concerning the Connected Transactions 2003, the greater than 0.03% baht but less than 3% of NTA because the acquisition equivalent to 0.12% of the value of net tangible assets which is a maximum transaction value calculated from the reviewed consolidated financial statements as of 31 March 2020, is categorized as a medium size transaction and required to be approved by the Board of Directors and revealed to the Stock Exchange of Thailand.
