Dental services segment

The Group have revenue from dental service in the amount of Baht 149.4 million which increased by Baht 2.1 million or 1% comparing to prior period because in 2020, the Company has temporarily suspended its operations according to the order of government agencies for a period of 1.5 months as a result of the COVID-19 epidemic, but in 2021 the Company was able to resume operations as usual but it was partially affected by the government's travel restriction policy.

Distribution of dental supplies and equipment segment

The Group have revenue from sales of dental supplies and equipment in the amount of Baht 54.9 million which increased by Baht 19.3 million or 20% comparing to prior period primarily due to the recognition of revenue from government projects and the sale of dental equipment products to the public and private sectors has increased.

The dental services segment had gross margins decreased from the previous year mainly due to the rental and service expense and employee benefit expense comparatively increased as the Company has more opening dates in 2021.

The distribution of dental supplies and equipment segment had a lower gross profit margin from the previous year mainly due to lower gross margins of government projects. This is because projects that are delivered in 2021 are projects that require hiring and using equipment from other companies. While, the project in 2020 were dental equipment imported by the Company.

Distribution costs

Distribution costs decreased by Baht 1.8 million for the sixth-month period but increased by Baht 3.0 million for the three-month period ended 30 June 2021 because in 2020, the Company has temporarily suspended its operations according to the order of government agencies for a period of 1.5 months, resulting in a reduction in employee benefits expenses. The cost of advertising and promotion has also decreased as well. However, the Group will be able to operate normally in 2021, resulting in higher expenses.

Administrative expenses

Administrative expenses decreased by Baht 7.5 million for the sixth-month period and have no changes for the three-month period ended 30 June 2021 mainly came from the reduction of rental and service fees including the cooperation of employees with expense reduction policies.

Finance costs

Finance costs decreased by Baht 1.9 million for the sixth-month period and decreased by Baht 0.4 million for the three-month period ended 30 June 2021 mainly came from the decreases in principal and the decreases in interest rates of loans.

The Group has net loss amounting to Baht 13.5 and 11.2 million for the six-month and three-month periods ended June 30, 2021, respectively. In the second quarter of 2021, the net loss increased when compared to the same period of the previous year as the Company was affected by the severe outbreak of the COVID-19 epidemic between April and June. Although the Group was able to resume operations as usual but the number of customers who come to use the service has decreased due to the restriction measures.

Total Assets

The total assets increased by Baht 8.7 million or 1%. The increase was mainly due to the increase of trade accounts receivable which in line with higher product sales in 2nd quarter and the inventories that the Company purchased for preparing of delivery to customers in government projects in the 3rd quarter.

Total Liabilities

The total liabilities decreased by Baht 24.4 million or 4%. The increase was mainly due to the increase in in short-term borrowings from financial institutions that are import credit which corresponds to an increase in inventories.

• Total Shareholders' equity

Total shareholders' equity decreased by Baht 15.7 million due to loss from operation and cash dividend payment.
