The Company would like to submit the reviewed financial statements with explanations of the changes of net profit as follows:

 Operating revenues for the second quarter of Year 2021 was Baht 4,758.90 million, increased by Baht 190.12 million or 4.16% from the same period of the previous year. The increase was due to growth of revenue from sale of high-rise projects as follows:

Gross profit for the sixmonth period ended June 30, 2021 was Baht 2,685.74 million, increased from the same period of the previous year by Baht 134.77 million or 5.28% in response of growth of revenue.
- Selling expenses for the second quarter of Year 2021 increased from the same period of the previous year by Baht 35.49 million or 11.63%. Selling expenses for the six-month period ended June 30, 2021 increased from the same period of the previous year by Baht 35.09 million or 6.14% in response of growth of revenue from sales. Administrative expenses for the second quarter of Year 2021 decreased from the same period of the previous year by Baht 33.05 million or 7.09%.
