The Company's total revenue of the 2nd quarter of year 2021 (April - June 2021) was 90.40 million Baht, decreased from the same quarter of Year 2020 by 5.46 million Baht or approximately 5.70%. The core revenue from Ferry service was 83.67 million Baht, equivalent to 92.56% of total revenue, decreased from the same quarter of Year 2020 by 4.56 million Baht or 5.17%. Due to the situation of the coronavirus (COVID-19) infection epidemic since the beginning of Year 2020, Thai tourists delay their travel and foreigners are still unable to travel in Thailand.

The company has net loss in the 2nd quarter of Year 2021 in the total of 38.33 million Baht, equivalent to 43.40% of total revenue, increased from the same quarter of Year 2020 at 12.78 million Baht, or equivalent to 50.02%.
