Major Development Public Company Limited (the "Company") would like to inform that the Company's Board of Directors meeting no. 10/2021, held on 22 July 2021 has resolved that Healthscape Co., Ltd.* as the Company's subsidiary invested on shares in Cubixcode Co., Ltd. by purchasing the shares from Ms. Ornnicha Srichaithumrong Mr. Teshin Juengkarawat and Mrs.Jumnian Kongchuay in amount of 5,100 shares, equivalent to 51%** with total investment of Baht 6,000,000. The main objective of the investment is to develop and design application platform to support Healthscape Co., Ltd. and the group Company's works. The details of invested company are as follows:
