The Group has total revenues for the 2nd quarter of 2021 amounted Baht 120.08 million, an increase of Baht 65.99 million or 122.00% compared to the total revenues of Baht 54.09 million for the 2nd quarter of 2020. The details are as follows:

### Palm oil trading business

The Group has no revenue from palm oil trading business for the 2nd quarter of 2021. It is due to the economic slowdown and the Covid-19 pandemic situation is still the main factor which effects to all over the world, resulting in an economic slowdown. Moreover, the price of palm oil is highly fluctuated. Therefore, the Company has slowed down trading of palm oil to reduce expenses and risks. That may arise from the palm oil trading business.

## Consulting and property development business

Revenue from consulting and property development business the 2nd quarter of 2021 amounted Baht 94.90 million, an increase of the total amount compared to the revenues for the 2nd quarter of 2020. It is due to IKON77 is the first real estate development project and the construction project has completed and begin to transferred ownership and recognize revenue in the 4th quarter of 2020. As a result, revenue from consulting and property development business in the 2nd quarter of 2021 increased from the total amount of the 2nd quarter of 2020.

The Group has gross profit for the 2nd quarter of 2021 amounted Baht 27.39 million, an increase of Baht 26.89 million or 5,378.00% compared to the gross profit of Baht 0.50 million for the 2nd quarter of 2020. The details are as follows: Palm oil trading business

Gross profit of palm oil trading business will be at the rate not more than 5% because the cost of goods sold is include all related expenses in the selling price from the distributor such as freight charges, etc. For the 2nd quarter of 2021, the Group has no revenue from palm oil trading business. It is due to the economic slowdown and the Covid-19 pandemic situation is still the main factor which effects to all over the world, resulting in an economic slowdown. Moreover, the price of palm oil is highly fluctuated. Therefore, the Company has slowed down trading of palm oil to reduce expenses and risks. That may arise from the palm oil trading business.

## Consulting and property development business

Gross profit from Consulting and property development business for the 2nd quarter of 2021 amounted Baht 27.39 million or 28.86%, an increase of Baht 27.67 million compared to loss of Baht 0.28 million for 2nd quarter of 2020. It is due to the IKON77 is the first real estate development project and the construction project has completed and begin to transferred ownership and recognize revenue in the 4th quarter of 2020. As a result, gross profit from consulting and property development business in the 2nd quarter of 2021 increased from the total amount of the 2nd quarter of 2020.

Other income

Other income for the 2nd quarter of 2021 amounted Baht 25.18 million, an increase of Baht 24.02 million compared

to other income of Baht 1.16 million for 2nd quarter of 2020. Most of the other income for the 2 second quarter of

2021 is revenue from forfeiture of down payment amounted to Baht 24.17 million baht. Because the customer does

not comply with the conditions specified in the Sale and Purchase Agreement for Condominium, such as late

payment consecutive instalments, fails to make down payment on the due date, or not transfer the condominium

unit's ownership within the appointed time, etc., resulting in the Group has entitled to exercise its right to terminate

the agreement and forfeit down payment from the customer in accordance with the policies and procedures of the

Group.

Distribution costs

The Group has the distribution costs for the 2nd quarter of 2021 amounted Baht 18.34 million, an increase of Baht

14.62 million or 393.01% compared to the distribution costs of Baht 3.72 million for the 2nd quarter of 2020.

Most of the distribution costs for the 2nd quarter of 2021 is distribution costs of transfer to ownership of IKON77.

In addition, the Group has sold the new real estate development project "IKON UDOMSUK", since the 4th quarter of

2020, resulting in higher distribution costs.

Administrative expenses

The Group has the administrative expenses for the 2nd quarter of 2021 amounted Baht 10.22 million, an increase of

Baht 11.90 million or 708.33% compared to the administrative expenses for the 2nd quarter of 2020. The recurring

administrative expenses increase of Baht 3.47 million due to the expansion of property development business.

The non-recurring administrative expenses increase of Baht 8.43 million due to the reversal estimated loss from cost

over income amounted Baht 9.66 million in the 2nd quarter of 2020.
