- Number of branch as of December 31, 2020 is 402 increased by 106 branches from December 31, 2019.
- Account receivables Portfolio as of December 31, 2020 is 7,733 Million Baht increased by 199 Million Baht from December 31, 2019.
- Net profit for the year ended December 31, 2020 is 318 Million Baht or equivalent to net profit margin of 20.00%.
 - Credit cost ratio as at December 31, 2020 is 2.20%, (as at December 31, 2019: 5.00%)
- Debt-to-Equity Ratio (D/E) as at December 31, 2020 is 1.37 times. (as at December 31, 2019: 1.42 time)

The operating performance for the year ended December 31, 2020 of the Company has total net profit of 318 Million Baht, increased from the same period in the previous year by 129 Million Baht or 68.57
