Subject: Notification of the purchase of shares and Restructuring shareholding of Cannabitec Co., Ltd.

Chaopraya Mahanakorn Public Company Limited (the "Company") to inform the Board of Directors' Meeting No. 6/2021 held on October 19, 2021, there were important resolutions as follows:

1) approved the purchase of shares from Mr. Wichian Padhayanun 248 shares with par value per share of 100 baht and Mr. Waradhapob Phaettayanan 248 shares with par value per share of 100 baht and Mr. Songsak Nikornmalakul 1 shares with par value per share of 100 baht. The total of shares held by the Company 497 shares with par value of 100 baht amount 49,700 baht or 99.4% of the total registered capital.

The transaction is considered a connected transaction in the category of asset or service transaction because purchase of shares from Mr. Wichian Padhayanun, Managing Director and Mr. Waradhapob Phaettayanan, a group of major shareholders of Chaopraya Mahanakorn Public Company Limited and is still an existing shareholder of Cannabitec Company Limited, holding 99.2% of the total shares with voting rights. therefore, being a connected person According to the Notification of the Capital Market Supervisory Board No. TorJor. 21/2551 Re: Rules for Connected Transactions and the Notification of the Board of Governors of the Stock Exchange of Thailand Re: Disclosure of Information and Company Operations Listed on the Connected Transaction B.E. 2003 (and as amended) ("Notification of the Connected Transaction") with the value of the connected transaction equal to 49,700 baht, which is less than 1 million baht and is considered a value less than 0.03%NTA (equal to 812,764.50 baht) is considered a small transaction. The Company is not obligated to disclose information on connected transactions to the Stock Exchange of Thailand.

This transaction is considered as an acquisition of asset in accordance with the Notification of the Capital Market Supervisory Board No. TorChor. 20/2551 Re: Rules on Entering into Material Transactions Deemed as Acquisition or Disposal of Assets (as amended), and the Notification of the Board of Governors of the Stock Exchange of Thailand Re: Disclosure of Information and Other Acts of Listed Companies Concerning the Acquisition or Disposal of Assets B.E. 2547 (2004) (as amended) (collectively referred to as the "Notification of Acquisition or Disposal"). The highest transaction size calculated based on the criteria of the value of net tangible assets is equal to 0.001 percent (referenced from the consolidated financial statements of the Company period ending 30 June 2021)



2) approved the increased capital in Cannabitec Company Limited (which is a direct subsidiary holding 99.4%) from registered capital of 50,000 baht divided into 500 shares with par value per share of 100 baht to registered capital of 1,000,000 baht divided into 10,000 shares with par value per share of 100 baht. to utilize as a working capital and enhance the potential of Cannabitec Company Limited.
