Subject Management's Discussion and Analysis for the three-month period ended September 30th, 2021.

The Company and its subsidiaries ("the Group") would like to report factors that affect the financial performance for the consolidated financial statements for the three-month period ended September 30th, 2021 as follows;

• <u>Net profit (loss)</u>

The Group has net loss amounting to Baht 4.1 million for the three-month period ended September 30, 2021. In the third quarter of 2021, the net loss increased when compared to the same period of the previous year as the Company was affected by the severe outbreak of the COVID-19 epidemic between April and August. Although the Group was able to resume operations as usual but the number of customers who come to use the service has decreased due to the restriction measures. However, in September 2021, the Government relief the lock down measure, so the Group has a better performance and has no loss incurred in the particular month.

Dental services segment

The Group have revenue from dental service in amount of Baht 56.9 million which decreased by Baht 26.6 million or 32% comparing to prior period because in 2020, the Company has temporarily suspended its operations according to the order of government agencies for a period around 2 months as a result of the COVID-19 epidemic.

Distribution of dental supplies and equipment segment

The Group have revenue from sales of dental supplies and equipment in amount of Baht 66.7 million which decreased by Baht 29.7 million or 31% comparing to prior period primarily due to the delay of purchase from government projects and the sale of dental equipment products from the public and private sectors affecting by COVID-19 situation.

• Cost of sales and rendering of services

The dental services segment had unchanged gross margins from the previous year mainly due to the cost controlling of rental and service expense and employee benefit expense.

The distribution of dental supplies and equipment segment had a lower gross profit margin from the previous year mainly due to lower gross margins of government projects. This is because projects that are delivered in 2021 are projects that require hiring and using equipment from other companies. While, the project in 2020 were dental equipment imported by the Company.

Distribution costs

Distribution costs decreased by Baht 3.9 million as in line with decrease in revenue from sales.

Administrative expenses

Administrative expenses decreased by Baht 3.2 million mainly came from the reduction of rental and service fees including the co-operation of employees with expense reduction policies.
