Asia Capital Group Public Company Limited ("the Company") would like to inform that the Company hasalready disclosed financial statements for the three months ending September 30, 2021 which has been reviewed by the auditor. The Company would like to clarify the changes of operating results compared to the same period of the year 2020. Net loss increased 77.27 million baht which more than 20%. The main reasons were as follows:

1. Interest income of the Company and subsidiaries decreased 8.20 million baht compared to the same period of the last year mainly from due to no new loans As well as having Some debtors defaulted on payment, resulting in stopping revenue recognition.

2. The Company and its subsidiaries had profit from sale of investment in subsidiary and other income decreased from the same period of the previous year by 73.52 million baht.

3. The Company and its subsidiaries had interest expenses decreased from the same period of the previous year by 8.89 million baht the reason is 2021 the company did not pay any fees for the sale of debentures, the auditor has classified the fees as interest expenses. As a result, interest expenses are reduced.

4. The Company and its subsidiaries recognized an increased in the administrative expenses in the amount of 1.90 million baht compared to the same period from the previous year the reason was mainly is loss on credit of receivables.

5. The Company and its subsidiaries recognized a decreased of 0.21 million in financial cost when compared with the same period from the previous year.

6. The Company and its subsidiaries had corporate income tax increased from the same period last year by approximately 1.55 million baht.

7. The Company and its subsidiaries had a decrease in profit of the minority shareholders of approximately 0.68 million baht.
