Management Discussion and Analysis

Executive Summary Quarter 3/2021 Performance

Wattana Karnpaet Public Company Limited ("Company") reported the total income in Quarter 3 Year 2021 to be Baht 76.444 million, decreased from Quarter 3 Year 2020 Baht 76.763 million or decreased by 0.42 per cent. The income comprises of the hospital's income of Baht 75.655 million in 2021, decreased from Baht 75.730 million or decreased by 0.1 per cent from last year. And the other income of Baht 0.789 million in 2021, decreased from Baht 1.033 million from last year, or decreased by 23.68 per cent. The decrease in income was due to the Covid-19 crisis situation which led to decrease in income of inpatients, however, the outpatient income was increased from the Covid-19 vaccination activities.

In Quarter 3/2021, the Company has EBITDA of Baht 8.614 million, which decreased from Baht 8.584 million in the same quarter last year, or decreased by 0.35 per cent.

The Company reported net profit of Baht 0.006 million, decreased from Baht 0.213 million, or decreased by 96.95 per cent from the same quarter last year, or the net profit of 0.00 Baht per share.

Quarter 3/2021 Financial Summary Operating Income

Cost and Expenses

In Quarter 3/2021, the Company has the total cost and expenses of Baht 75.835 million, decreased from Baht 75.949 million of last year, or a 0.15 per cent decreased from last year.

The cost of hospital operations in Quarter 3/2021 was Baht 62.955 million, increased from Baht 61.333 million of last year, or increased by 2.64 per cent. The increase in cost of operations was mainly due to the increase usage of Personal Protection Equipment (PPE) and the increase in vaccines used.

The administrative expenses in Quarter 3/2021 was Baht 12.881 million, decreased from Baht 14.616 million of last year, or decrease of 11.88 per cent.
