## **Operating results**

The Company realized 438.51 million baht for revenue from canned seafood products and food services and others in the Quarter 3/2021 which compared to revenue of Quarter 3/2020 was 299.65 million baht increased by 138.86 million baht or (46.44%). While the cost of sales and services was 316.78 million baht in Quarter 3/2021, compared to cost of sales and services was 237.95 million baht in Quarter 3/2020, increased by 78.83 million baht or (33.13%) because the cost of sales and services were increased by the same direction of the revenue. Distribution costs amount 38.93 million baht in Quarter 3/2021 compared to Quarter 3/2020 amount 27.68 million baht or increased by 11.25 million baht (40.64%) and the administrative expenses amount 85.95 million baht in Quarter 3/2021 compare to Quarter 3/2020 amount 37.21 million baht or increased 48.74 million baht (130.99%) administrative expenditures in this quarter were increased. The net loss in Quarter 3/2021 was 4.50 million baht, because of the voluntary resignation program in order to adjust the cost structure to the organization. For the nine months period ended at September 30, 2021 the company have still maintained net profit 39.70 million baht compared to the same period at September 30, 2020 we have net profit 24.05 million baht increasing 15.65 million baht (65.07%) from cumulative revenue of three quarters.
