Board of Directors E-Meeting of Solartron Public Company Limited (the "Company or "SOLAR") No. 9/2021 (the "BOD"), held on Monday, 15th November 2021, at 4:00 p.m., the important resolutions of the connected transection (Approved from the third quarter of 2018 until present)

The Company has received financial support from director in the type of PROMISSORY NOTE that value amount of 19.91 million baht that can extend the PN as agreed upon the payment is due with an interest rate at 5.0% per year.

1.5 Value of Transaction and Transaction Size:

The Company has received loans without guarantee in amount of 19.91 million baht that can extend the PN as agreed upon the payment is due with an interest rate at 5.0% per year. The transactions that have been entered are the new loan in such the total value as per the following details:

The above-mentioned loans, the Company was granted loans by issuing promissory notes due on demand. Connected transaction of PN value of 19.91 million baht with interest expense 0.995 million baht. (Calculated by 1 year term or 0.76% of Net Tangible Asset (NTA))
