private placement as a consideration for entire business transfer (Edited)

The Stock Exchange of Thailand

Reference is made to the Extraordinary General Meeting No. 1/2022 of of NCL International Logistics Public Company Limited (the "Company") held on January 25, 2022, which approved the investment in digital marketing services business by means of entire business transfer of BOB Holding Company Limited ("BOB") which include all assets, debts, liabilities, and all obligations of BOB at the present or in the future on the transferring date. In this regard, the Company the consideration for the entire business transfer to BOB in an amount of THB 250,189,432.20 by issuance and offering of up to 72,518,686 newly issued ordinary shares, with a par value of THB 0.25 per share by way of the issuance and offering of newly issued ordinary shares to specific persons (Private Placement), where the offering price per share shall be equal to 90 percent of the volume weighted average price of the Company's ordinary shares during 7 consecutive business days prior to the date on which the board of directors' meeting of the Company approve the determination of offering price. In the event that the offering price is higher than THB 3.45 per share, the number of shares to be issued by the Company for the payment of consideration for BOB's shares shall be decreased, calculated based on the transaction size of THB 250,189,432.20 divides such offering price. However, the offering price shall not less than THB 3.45 per share.

The Company would like to inform that the Board of Directors' Meeting of the Company no. 1/2022, held on January 31, 2022, resolved to approve the number of newly issued ordinary shares, final offering price, subscription and payment date for the issuance and offering of the newly issued ordinary shares to BOB, with the following details:

- 1. Number of final newly issued ordinary shares to be issued and offered is 62,081,745 shares, with a par value of THB 0.25 per share
- 2. Subscription and payment dates for the newly issued ordinary shares on January 31, 2022
- 3. The final offering price is THB 4.03 per share, totalling THB 250,189,432.35, by which the said offering price is equal to 90 percent of the volume weighted average price of the Company's ordinary shares during 7 consecutive business days prior to the date on which the board of directors' meeting of the Company approve the determination of the final offering price i.e. from January 20, 2022 to January 28, 2022, which is equivalent to THB 4.48 per shares (information from SETSMART: www.setsmart.com). In this regard, the final offering price is not considered as an offering of newly issued shares at the price lower than 90 percent of the market price pursuant to the Notification of the Capital Market Supervisory Board No. TorChor. 72/2558 Re: Approval for Listed Companies to offer Newly Issued Shares through Private Placement (as amended).

In addition, the offering price of newly issued ordinary shares this time is not considered as the issuance and offering of private placement at the price lower than 90 percent of the market price (the market price means the volume-weighted average price of the Company's ordinary shares traded on the stock exchange of Thailand (the "SET") during not less than 7 consecutive business days but not more than 15 consecutive business days before 31 January 2022 which is the first offering date, and shall be not subject to the period of restriction on selling shares (silent period) pursuant to the Notification of the Stock Exchange of Thailand Re: Rules, Conditions and Procedures Governing the Listing of Ordinary or Preferred Shares Issued for Capital Increase B.E. 2558 (2015).
