Ref: Consolidated financial statements of Business Online Public Company Limited and its subsidiaries for the year ended 31 December 2021 and separate financial statements of Business Online Public Company Limited.

On 11 February 2022, Board of Directors of Business Online Public Company Limited (“the company”) has a resolution to approve the consolidated financial statements and the separate financial statements for the year ended 31 December 2021 which were audited by a Certified Public Accountant. The operating results for the year 2021 have presented on the consolidated financial statements and the separate financial statements of comprehensive income as follows:

**1. The consolidated financial statements of Business Online Public Company Limited and its subsidiaries.**

**1.1 The operating results for the year 2021 of the company and its subsidiaries compared to the year 2020**

In 2021, the company and its subsidiaries had net profit of Baht 233.21 million which increased by Baht 54.71 million, or 30.65% compared to the net profit in the last year. The main reasons were as follows:

- A. The company and its subsidiaries presented a total revenues of Baht 650.49 million, increased by Baht 24.28 million or 3.88% compared with the total revenues in the last year. The main reason was an increase in revenues from providing business information.
- B. The company and its subsidiaries had costs of services and administrative expenses of Baht 374.55 million, presenting a decrease of Baht 42.89 million or -10.28% compared with the costs of services and administrative expenses in the last year. This was mainly attributed to the decrease of the costs of services in 2021 by Baht 30.52 million or -12.05% compared to the last year.

## **2. The separate financial statements of Business Online Public Company Limited.**

### **2.1 The operating result for the year 2021 of the company compared to the year 2020.**

In 2021, the company had net profit of Baht 225.62 million which increased by Baht 41.61 million or 22.62% compared to the net profit in the last year. The main reasons were as follows:

- A. The company presented a total revenues of Baht 576.19 million, increased by Baht 9.51 million or 1.68%, compared with the total revenues in the last year. The main reasons were from the increased in revenues from providing business information and other income.
  
- B. The company had costs of services and administrative expenses of Baht 315.22 million, presenting a decrease of Baht 40.01 million or -11.26% compared with the costs of services and administrative expenses in the last year. This was mainly attributed to the decrease of the costs of services in 2021 by Baht 31.50 million or -14.84% compared to the last year.
