Subject: Report of the Company's operating result for the year ended December 31, 2021

With respect to the operating results of Kiatnakin Phatra Securities Public Company Limited ("the Company") for the year ended December 31, 2021 was compared with the operating results of the Company for the prior year. Details were as below:

- 1. The Company's revenues in 2021 were Baht 5,366.93 million, increased by Baht 1,413.00 million or 35.74% from Baht 3,953.93 million in 2020.
- 2. The Company's net earnings in 2021 were Baht 1,772.44 million, increased by Baht 555.18 million, or 45.61%, from Baht 1,217.26 million in 2020. Together with other comprehensive income which was changes in fair value of equity investments of Baht 10.34 million, gain on disposal of equity investments of Baht 0.18 million, actuarial gain on define benefits plan of baht 10.96 million and income taxes through other comprehensive income of Baht 4.29 million. Total comprehensive income in 2021 was reported at Baht 1,789.63 million.

### **Revenues from Agency Business**

#### 1. Brokerage fees from securities business

In 2021, average daily trading value on the SET & MAI were Baht 93,846 million, increased from Baht 68,607 million in 2020.

Our average daily trading value (excluded securities trading of proprietary account) increased by 79.28% from Baht 13,323 million in 2020 to Baht 23,885 million in 2021. Brokerage fees from securities business in 2021 were Baht 1,692.91 million. Market share of the Company (excluded securities trading of proprietary account) in 2021 was 14.04%, ranked 1st from total 38 brokers.

### 2. Brokerage fees from derivatives business

Brokerage fees from derivatives business were Baht 171.91 million in 2021, decreased from Baht 225.82 million in 2020. Market share of the Company, measured by number of contracts in derivatives market, in 2021 was 9.17%.

In 2021, proportion of the brokerage fees from derivatives business from foreign institutional investors, local institutional investors and high net worth individuals were 72.80%, 0.55% and 26.65% respectively.

# 3. Other brokerage fees

Other brokerage fees in 2021 were Baht 76.68 million, mainly from tender offer agent fees Baht 15.15 million and others Baht 61.53 million.

#### 4. Fees and services income

Fees and services income in 2021 was Baht 2,113.83 million, increased from Baht 1,003.32 million in 2020. Total fees and services income in 2021 consist of Baht 1,160.97 million from selling agent fees, Baht 261.04 million from financial advisory fees, Baht 574.55 million from underwriting fees, Baht 27.99 million from investment advisory fees, Baht 88.88 million from stock borrowing and lending fees and Baht 0.40 million from others.

The Company's total expenses in 2021 were Baht 3,149.36 million, increased by Baht 719.19 million or 29.59% from Baht 2,430.17 million in 2020 due to an increase in personnel expenses.

## **Net Earnings**

Due to the reasons discussed above, The Company's net earnings in 2021 were Baht 1,772.44 million, increased by Baht 555.18 million, or 45.61%, from Baht 1,217.26 million in 2020. Together with other comprehensive income which was changes in fair value of equity investments of Baht 10.34 million, gain on disposal of equity investments of Baht 0.18 million, actuarial gain on define benefits plan of baht 10.96 million and income taxes through other comprehensive income of Baht 4.29 million.
