3. Nature of Transaction

Unique Mining Services Public Company Limited has entered into an office space rental agreement with Thoresen Thai Agencies Public Company Limited, which is a connected transaction. with details as follows: The Company rents the office address 26/23 Orakarn Building, 7th Floor, Soi Chidlom, Ploenchit Road, Lumpini , Pathumwan , Bangkok 10330, with a total area of 270 square meters, and the rental rate is 81,000 baht per month (300 baht per 1 square meter) for a period of 1 year from 1 January – 31 December 2022. The total value throughout the contract period is equal to 972,000 baht and has a common service fee of 40,500 baht per month (150 baht per 1 square meter) for a period of 1 year from January 1 - December 31, 2022. The total value over the contract period is 486,000 baht, totaling 121,500 baht per month or 1,458,000 baht per year.

4. Total value of Connected Transaction

Unique Mining Services Public Company Limited leases office space from Thoresen Thai Agencies Public Company Limited for one year. The rental value of office space including common fee is 121,500 baht per



month or it is equal to 1,458,000 baht per year, calculated from the rental rate, including the common area fee, equal to 450 baht per square meter per month, which is a price that is lower than or close to the general market price

5. Size of Connected Transaction

Calculation the criteria to determine the value as following

The value of rental fee per year *100 / Net Tangible Asset

= 1,458,000 *100 / 170,925,344

= 0.85%

The size of the transaction is equal to 0.85% of net tangible assets which is calculated from the financial statements audited as at December 31, 2021. UMS has disclose the transaction to investors.
