Which has net profit Baht 737.52 million, increased by 79.81% when compared to the previous year. The Company would like to clarify the significant change in operating result as the following:

- 1. Revenue from Sales was Baht 6,520.81 million, which increased by Baht 917.78 million or 16.38% as the average selling price was increased by 16.38% according to the significant increasing of steel price trend.
- 2. Gross profit margin was 17.62%, increased from same period of previous year that gross profit margin was 13.16% due to the increasing of selling price and the efficiency of inventory management.
- 3. Selling and Administrative Expenses was Baht 235.32 million decreased by Baht 12.19 million or 4.93% when compared to same period of previous year due to the decreasing of quantity of sales.
- 4. Financial Cost was Baht 1.72 million, decreased by Baht 6.24 million or 78.39% Due to decreasing of the loan from financial institutions for working capital when compare to the same period of previous year.
