We would like to inform that the company has net loss for the year ended 31 December 2021 amounting to Bht 64.86 million. The net loss increases from last year of Bht 33.64 million or 107.74 percent. This is due to the details as following:

## Sales and Services Income

Sales and service income of this year decreases in an amount of Bht 116.77 million, or 23.43 percent from the last year. This is due to the delay of project delivery, the change of buyer behavior caused from economic down trend effected by Covid-19

## **Gross Profit**

Gross profit is Revenue deduct cost of goods sold which include raw material, direct labor and overhead. In 2021 our gross profit decrease of baht 54.41 million or 36.27 percent. Gross margin from sale and services decreases from 30.10 in 2020 to 25.05 in 2021 due to the increase of cost of steel and wood which are one of our main materials. Moreover, we are having high proportion of fixed cost than variable cost, the decrease of sale and service are affect the gross margin.

## Selling and Administrative Expenses

Selling and Administrative expenses mainly are Employee expense, Rental, Utilities expense, Marketing expense and Depreciation and Amortization expense. In 2021 Selling and Administrative expenses decrease from 174.47 million baht in 2020 to 157.67 million baht in 2021 or 9.63 percent due to strictly expenses control policy but with no effect to staff salary expense.
