# **Executive Summary**

In year ended of December 31,2021, the Company had the total revenue of Baht 636.15 million, increased of 15.60% YOY. Total cost of sales and services amount of Baht 510.07 million, increased of 17.27% YOY. Resulting the higher gross profit amount of Baht 126.08 million, a growth of 19.82% YOY. Distribution costs and administrative expenses amount of Baht 94.65 million, increased of 3.99% YOY. Net profit for the twelve-month period amount of Baht 24.85 million, increased to 4.00% in 2021 from 29.77% YOY, and EBITDA through the year 2021 amount of Baht 47.12 million.

The Company's major reasons for the performance for 12 months of 2021, The revenue had increased with impact from Product Revenues, especially sale to Civil such as Electricity Generating Authority, also the corporate as gets job from government, including mainly impact from raw material cost such steel price are raise the price, hence cost of production and cost of goods sold were raise.

## Total revenues

The period twelve-month ended of December 31, 2021, the Company had the total revenue amount of Baht 636.15 million, consist of revenue from sales amount of Baht 382.63 million, increased amount of Baht 73.13 million, increased of 23.63% YOY (Compared by percentage to revenue). Decreased from the third quarter amount of Baht 28.84 million, decreased of 25.37%. Revenues from construction amount of Baht 249.57 million, increased from same period from last year amount of Baht 13.06 million, increased of 5.52% YOY. Revenue from construction is increased from the third quarter amount of Baht 1.03 million, increased of 1.44%.

For revenue from sales, mainly increased from concreate sold volume, revenue from construction, quiet closely with 2020, revenue from service amount of Baht 2.18 million, increased of 26.74%, other revenue amount of Baht 1.77 million, deceased of 31.40%

The period twelve-month ended of December 31, 2021, the Company had the total Cost of sales and service amount of Baht 298.84 million(78.10%), increased by amount of Baht 74.42 million, increased of 33.16% YOY, Cost of sales and services had increased with impact from sales volume in concreate products also steel cost is raised.

### Cost of construction

The period twelve-month ended of December 31, 2021, the Company had the total Cost of construction amount of Baht 211.23 million (86.64%), increased from same period from previous year amount of Baht 0.70 million (0.3%) and decreased from the third quarter 2021 amount of Baht 9.16 million (14.45%) as a result of work of construction 230 KV Chantaburi-Trad (4 Circles)-Project had been decreased cost of construction also with 330-Project the project did decreased too, as a result of the project could offered tools and equipment with low cost.

## Distribution costs and administrative expenses

There were mainly impacted from Oil and Gas in transportation expenses also from employee's bonus payment.

The period twelve-month ended of December 31, 2021, the Company's gross profit amount of Baht 126.08 million, increased from same previous amount of Baht 10.72 million (9.30%), increased from the third quarter amount of Baht 1.61 million (4.50%). Profit(loss) after corporate income tax for the period amount of Baht 24.85 million, increased from same period from last year amount of Baht 5.70 million (29.77%), increased from the third quarter amount of Baht 0.93 million (9.74%), there were mainly impact from Total revenue were increased, Total cost were increased. Earning per share was amount of baht 0.06 EBITDA was amount of Baht 47.12 million.
