Subject: Partial Divestment in a subsidiary

SVI Public Company Limited ("SVI" or the "Company") would like inform that on March 1, 2022 SVI (Austria) GmbH ("SVI (Austria)"), a wholly owned subsidiary of the Company, has signed a Share Purchase Agreement to divest 49% ("First Transaction") of its shareholding in SVI Hungary Kft. to ml&s Personalservice GmbH and ESCHA GmbH & Co. KG (collectively the "Purchasers"). SVI (Austria) will continue to be a major shareholder in SVI Hungary Kft. with 51% ownership for an interim period of 2 years, and, thereafter, the Purchasers will acquire the remaining 51% ("Second Transaction"). The new partnership brings great news to the SVI Group and, especially, to SVI Hungary Kft. as the Purchasers will significantly increase SVI Hungary Kft.'s revenues with new businesses as well as provide investments in new equipment. duotec with its subsidiary ml&s GmbH & Co. KG is a leading German electronic manufacturing services & technology providers with consolidated revenues of over EUR 230 million.

The value of the acquisition, calculated in accordance with the regulations of the Capital Market Supervisory Board and the Stock Exchange of Thailand, as prescribed by the regulations of the Stock Exchange of Thailand Re: Disclosure of Information and Other Acts of Listed Companies Concerning the Acquisition and Disposition of Assets, 2004 (as amended), is less than 15 percent and the total size of all transactions in the past 6 months also does not exceed the 15 percent threshold limits as prescribed in the regulations.
