Total Revenue

For the 1Q22, the Company and its subsidiaries generated a total revenue of 476.22 million baht, which is income increased of 19.26 million baht or 4.21% increased from the 1st Quarter of previous year. The real estate revenue of 460.80 million baht increased of 18.90 million baht or 4.28% decreased from the 1st Quarter of previous year.

For the 1Q22, Compare with the 1st Quarter of previous year.

Revenue from townhouses was 274.16 million baht, increase of 88.73 million baht or 47.85%

Revenue from single-detached house was 151.83 million baht decreased 62.26 million baht or 29.08%

Revenue from condominium was 34.82 million baht, an decrease of 7.55 million baht or 17.82%

Cost of real estate sales

For 1Q22, the Company and its subsidiaries incurred cost of real estate of 238.51 million baht or 51.76% of the revenue from real estate as compared to 1Q21 revenue from real estate was 261.20 million baht or 59.11% of the real estate revenue while the real estate cost in 1Q22 decreased of 8.69% from 1Q21

Selling & Administrative expense

For 1Q22, the Company and its subsidiaries incurred selling and administrative expenses of 109.79 million baht or decrease of 5.64 million baht or 4.89%

Financing cost

For 1Q22, the Company and its subsidiaries incurred financing cost of 25.02 million baht or 5.25% of total revenue, increased of 8.36 million baht or 50.20% compare with the 1st Quarter of previous year.

Income tax expenses

Income tax expenses for 1Q22 were 21.82 million baht or 4.58% of total revenue, an increased of 8.11 million baht from the 1^{st} Quarter of previous year

Net profit

For 1Q22, the net profit of the Company and its subsidiaries was 72.17 million baht or 15.16% of total revenue, an increased of 31.94 million baht or 79.41% increased from the 1st Quarter of previous year.
