Executive Summary

In year ended of three-month as at 31 March 2022, the Company had the total revenue of Baht 180.93 million, increased of 10.80% YOY. Total cost of sales and services amount of Baht 158.63 million, increased of 19.29% YOY. Resulting the higher gross profit amount of Baht 22.30 million, a growth of 12.33% YOY. Distribution costs and administrative expenses amount of Baht 22.07 million, decreased of 3.62% YOY. Net loss for the three-month period amount of Baht 0.21 million, 0.12% decreased from same period with previous year amount of Baht 6.11 million, 103.55% YOY, and EBITDA in the first quarter of 2022 amount of Baht 3.63 million.

The Company's major reasons for the performance for the first-quarter of 2022, Net loss was impact from sales-price competition, including mainly impact from raw material cost such steel price are raise the price, hence cost of production and cost of goods sold were raise also labor cost.

Total revenues

The period three-month ended of March 31, 2022, the Company had the total revenue amount of Baht 180.93 million, 10.83%, consist of revenue from sales amount of Baht 90.31 million, decreased 9.59%, consideration with Q'1/2022 revenue from sale, it's decreased from previous year, but revenue from construction amount of Baht 89.23 million, increased 42.02%, revenue from service amount of Baht 0.69 million, increased 130% and other revenue amount of Baht 0.69 million, 21.05%

The period three-month ended of March 31, 2022, the Company had the total distribution costs and administrative expenses amount of Baht 22.07 million, with 12.20%YOY of total revenue, decreased by amount of Baht 0.83 million, 3.62%YOY.Distribution costs was increased, there were mainly impacted from Oil and Gas in transportation expenses but administration expenses were decreased, mainly decreased from employee's bonus payment, salary payment also with professional fee and bank fee.

From decreased in current liabilities amount of Baht 16.04 million, by decreased from account payable and current other payable amount of Baht 5.12 million. Decreased in current contract liabilities amount of Baht 11.57 million, also decreased in Non-current liabilities amount of Baht 1.39 million. There were changed from Finance Leasing, Long-term loan from financial institution and increased from provision for employee benefit.

Share holders
