Management Discussion and Analysis

Executive Summary Quarter 1/2022 Performance

Wattana Karnpaet Public Company Limited ("Company") reported the total income in Quarter 1/2022 to be Baht 134.030 million, increased from Baht 76.763 million, or increased by 74.60 per cent from Quarter 1/2021. This increase in income was due to the increase in the number of Covid-19 patients during the outbreak in the first quarter of the 2022.

The cost and expenses in Quarter 1/2022 comprises of cost of hospital operations of Baht 76.269 million, increased from Baht 59.952 million in last year, increased by 27.22 per cent. The increase in the cost of hospital operations was due to the increase in the number of patients. As for the administrative expenses was Baht 20.462 million, increased from Baht 13.967 million in last year, or by 46.50 per cent. Once included the financial cost of Baht 0.705 million, which decreased from Baht 0.959 million in last year, or by 26.49 per cent. The company has a profit before income tax of Baht 36.594 million, increased from Baht 1.885 million in the same quarter of last year, or by 1841.33 per cent. And in Quarter 1/2022, the company has income tax of Baht 7.281 million. This resulted in the Quarter 1/2022, company had the net profit of Baht 29.314 million, increased by 1718.49 per cent. Or net profit of 2.93 Baht per share, and the comprehensive income for the Quarter of Baht 29.314 million.

In the Quarter 1/2022 company's EBITDA of Baht 45.475 million, increased by 317.47 per cent from last year.
