The Total Revenues decreased by 7.010 million baht or 10.66%, with Total Expenses decreased by Baht 2.661 million or 4.49%. The Operation Results of the Company Only on the 1st quarter of 2022 was loss of 7.759 million baht.

The Net Profit of the 1st quarter of 2022 decreased by 3.644 million baht as compared to the 1st quarter of 2021 or decrease of Profit at 76.94%. The Total Revenues decreased by 7.110 million baht or 10.82%, with Total Expenses decreased by Baht 2.668 million or 4.47%. The Operation Results of the Consolidated on the 1st quarter of 2022 was loss of 4.736 million baht.

The Increase / Decrease of Financial Statement for the Company Only were by the results of the followings:-

- 1. Although in the 1st quarter of 2022, the economic situation and the Covid-19 situation would relatively improve, resulting in the Company's operations having a better trend, the Company was still affected by the past situation, resulting in Service Income of the 1st quarter of 2022 decreased by 7.357 million baht, or a decrease of 11.37% as compared to the 1st quarter of 2021.
- 2. The Total Expenses of the 1st quarter of 2022 decreased by 2.668 million baht or 4.47% as compared to the 1st quarter of 2021, by the results of
- 2.1 The Cost of Services in the 1st quarter of 2022 has decreased by 5.083 million baht or 11.38% as compared to the 1st quarter of 2021, in line with the decrease in service income. Anyway, the ratio of cost of service to the service income of the 1st quarter of 2022 and the 1st quarter of 2021 was very similar. The decrease in service income and the cost of service resulted in the gross profit of the first quarter of 2022 decreasing to 2.274 million baht.

2.2 The Administrative Expenses in the 1st quarter of 2022 has increased by 2.422 million baht or 16.57% as compared to the 1st quarter of 2021, which was an increase in administrative expenses of general items along with the rising of price level. Except for the 1st Quarter of 2022, the expenses were directly related to the implementation of the Company's new projects, for example, salary and advisory fees, as well as other related items increased by 4.80 million baht, together with a loss from the foreign exchange decreased by 2.50 million baht. The total administrative expenses in this group increased by 2.30 million baht, while the total administrative expenses have increased to 2.422 million baht.

2.3 The Financial Costs in the 1st quarter of 2022 have slightly increased by 0.095 million baht or 1.11% which has been in normal condition of investment in the Company's projects by credit loaning based on relevant conditions.

2.4 The Loss on Impairment of Financial Assets in the 1st quarter of 2022 decreased by 0.905 million baht, which was the increase / decrease in accordance with the Thai Financial Reporting Standards (TFRS) No. 9.

2.5 The Income Tax Expense in the 1st quarter of 2022 increased by 0.054 million baht or 245.45% as compared to the 1st quarter of 2021. The Income Tax Expense was calculated from accounting profit and adjusted with various expenses in order to be the income tax calculated from taxable profit, deferred income tax assets and liabilities, in accordance with TAS 12, Re.: Income Taxes.

3. PT. Thai NDT Indonesia (Debtor).

For the opportunity in the Republic of Indonesia, the Company is quite confident and supports policies that will promote future jobs. Indonesia is considered a source of work that will assist strengthen the Company's existing business base by creating innovations and new personnel, which will be clear in the future. In March 2022, in the midst of the crisis of the Covid-19 epidemic, the Company including alliances from both private and government agencies traveled to Indonesia to attend the capital relocation project, most of which are new resources of work, both NDT processes, expertise, and a network of alliances who have participated in the Company's activities for nearly 40 years to fulfill the development purpose.

For the reasons mentioned above, the profit (loss) of the 1st quarter of 2022 was in line with such amount.
