In the second quarter of 2022 The Company and its subsidiaries had total revenues of 69.00 million Baht, an increase of 20.41 million Baht from the year 2021, which had total revenues of 48.59 million baht or an increase of 42.00 percent. and from the business of processing rubber wood which is the main income of the company has expanded exports and increase production capacity including an increase in the lease of assets that the business from areas where the business is not operating for the best interest in the pursuit of profit Therefore, the business has increased revenue. Compared to the same period last year.

The Company and its subsidiaries had sales and service in 2022 in the amount of 63.61 million baht, an increase of 22.84 million baht from the year 2021 cost of Sales and Services of 40.77 million baht or an increase of 56.02 percent, as a result of increased income. The Company and its subsidiaries had distribution costs in 2022 in the amount of 6.99 million baht, increase of 1.77 million baht from the year 2021 which had expenses of 5.22 million baht or an increase of 33.91 percent.

While the second quarter of 2021, the Company and its subsidiaries had a loss operating results of 18.02 million baht, decrease of 3.12 million baht or a decrease of 17.31 percent.

From overall operations in the third quarter of 2022, the Company and its subsidiaries reported total revenues for the six month period ended June 30th, 2022 equivalent to 137.40 million Baht, an increase of 31.61 million Baht from the same period of 2021 which had the total revenue 105.79 million Baht or an increase of 29.88 percent and had a loss of 27.96 million baht, While in the second quarter of 2021, the operating results showed a loss of 32.72 million baht, a decrease of 4.76 million baht or a decrease of 14.55 percent.
