Service Revenue

Service income increased from by 10.14 million Baht or 11.24% from the same period of last year. This was a result of the recognition of project revenue which continued from the previous year when the Company continued the work in both public and private projects.

During the past two quarters, the company has realized the revenue and delivered short-term projects from the private sector which increased from the same period last year. Although some large projects will be affected by the adjustment of plans and actual service costs that affect the recognition of some parts of the revenues, by overall the company has seen some growths many projects, including short and long term projects.

The Company and its subsidiaries had costs from services increased by 5.51 million Baht from the same period last year. or 7.95% from the same period last year from recruiting staff to support job expansion which will affect the increase in the company's revenue and future subsidiaries.



Administrative expenses

The Company and its subsidiaries had administrative expenses decreased by 1.81 million Baht from the same period of last year or equivalent to 8.61% from the same period last year. The Company and its subsidiaries still maintain control and management of expenditures within the budget.

Net profit (loss) and net profit (loss) margin

For the three-month period ended 30th June 2022, the Company and its subsidiaries had a net profit of 8.30 million Baht, an increase of 4.51 million Baht from the previous period, representing a 119% increase in net profit of the same period last year. and has a net profit margin accounted for 8.27% of service revenue The increase in profit is related to the increase in service revenue.

As of 30th June 2022, the Company and its subsidiaries Total assets amounted to 637.73 million Baht, an increase of 38.73 million Baht from the end of 2021, resulting from an increase in other current receivables of 13.99 million Baht and unbilled income of 11.30 million Baht.

As of 30th June 2022, the Company and its subsidiaries Total liabilities amounted to 371.43 million Baht, an increase of 29.66 million Baht from the end of 2021. And a subsidiary received short-term loan from a financial institution.

As of 30th June 2022, the Company and its subsidiaries have shareholders' equity of 314.07 million Baht, an increase from the end of 2021 by 9.07 million Baht from net profit for the period.
