Management Discussion and Analysis

For the quarter 2/2022, the Company reported net profit of 26.40 million baht in the separate financial statements, and 23.71 million baht in the consolidated financial statements, increasing by 0.10 million baht or equivalent to 0.42 percent, compared to the same period of the previous year.

The Company's total revenues increased 55.82 million baht or 19.58 percent year-on-year, due to a rise in the product group of 'metal trunking and white conduit such as Don Mueang International Airport and the Forestias Bangna projects, as well as an increase in exports which have increasing growth trend.

The Company had selling and administrative expenses of 31.99 million baht, increased by 0.67 million baht or equivalent to 2.14 percent over the same period of the previous year due to the increase of sales revenue.

The Company reported a share of loss from investment in Nitto Kogyo BM (Thailand) Company Limited (NBT), an associated company, amounted to 2.68 million baht because the depreciation of plant and equipment was recognized at the beginning of production, after the start of operation in mid-2021. However, NBT undertakes to maintain and sustain consistent revenue growth. As a result, NBT delivered positive EBITDA in Q2/2022.

The Company sold all shares of MECT Company Limited, an associated company, in Q3/2021.

As of 30 June 2022, the Company's total assets were 1,534.41 million baht, increasing by 192.29 million baht, compared to 31 December 2021, primarily due to an increase of 49.68 million baht in the value of the plant and equipment for the construction of new factory in Free Zone, an increase of 46.05 million baht in trade receivables, and an increase of 34.08 million baht in inventories. The Company's Debt to Equity (D/E) ratio was 0.90.
