Executive Summary

In the year ended the sixth month as of 30 June 2022, the Company had total revenue of Baht 303.72 million, an increase of 4.55% YOY. The total cost of sales and services amounts to Baht 266.01 million, an increase of 11.96% YOY. Resulting in a higher gross profit amount of Baht 37.11 million, a growth of 12.22% YOY. Distribution costs and administrative expenses amounted to Baht 44.63 million, a decrease of 4.86% YOY. Net loss for the sixth month period amount of Baht 7.30 million, (2.40%) decreased from the same period with previous year amount of Baht 12.14 million, 250.80% YOY, and EBITDA in the second quarter of 2022 amount of Baht (0.21) million.

The Company's major reasons for the performance for the second quarter of 2022, the Net loss was impacted by the sales-price competition, including mainly impact from raw material costs such steel price raise the price also rising oil prices, hence cost of production and cost of goods sold were raise also labor cost.

Total revenues

The period the sixth month ended on June 30, 2022, the Company had a total revenue amount of Baht 303.72 million, 4.55%, consisting of revenue from sales amount of Baht 169.71 million, which decreased 7.83%, consideration with Q'2/2022 revenue from the sale, it's decreased from the previous year, but revenue from construction amount of Baht 131.68 million, increased 25.34%, revenue from service amount of Baht 1.18 million, increased 34.10% and other revenue amounts of Baht 1.15 million, 167.44%

Cost of sales and services

The period the sixth month ended on June 30, 2022, the Company had the total Cost of sales and services amount of Baht 266.01 million, 87.92%, an increasing amount of Baht 28.47 million, an increase of 11.96% YoY, Cost of sales and services had increased by the amount of Baht 142.40 million, increased of 83.91% YoY, there is Cost of construction increased by the amount of Baht 124.21 million, 94.33% YoY of total revenue. Mainly increased were impacted by the higher competition and the raise in the cost of the main raw material (steel).

The period of three months from April 1, 2022, to June 30, 2022, the Company had the total Cost of sales and services amount of Baht 107.97 million, 88.25%, a decreasing amount of Baht 50.66 million, 31.94% QoQ, Cost of sales and services had decreased by the amount of Baht 66.33 million, 83.54% QoQ, there is the Cost of Construction amount of Baht 41.64 million, 98.09%. Mainly decreased were impacted by sales volume were lower than the last quarter, because of the guideline company competition also with mostly the Revenue of Construction was recognized.

Distribution costs and administrative expenses

The period the sixth month ended on June 30, 2022, the Company had a total distribution costs and administrative expenses amount of Baht 44.63 million, with 14.75%YoY of total revenue, decreased by an amount of Baht 2.28 million, 4.86%YoY. Distribution costs were decreased, there were mainly impacted by Oil and Gas transportation expenses but administration expenses decreased, mainly decreasing from employee's bonus payments, salary payments also with professional fees, and bank fees.

The period the three months from April 1, 2022, to June 30, 2022, the Company had a total distribution costs and administrative expenses amount of Baht 22.57 million, with 18.45% QoQ of the total revenue, there is rising in the amount of Baht 0.50 million, with 2.27% QoQ. As a result of Oil and Gas transportation expenses but administration expenses decreased, mainly decreasing from employee's bonus payments, salary payments also with professional fees, and bank fees.

Gross Profit and Net Profit

The period the sixth month ended on June 30, 2022, the Company's gross profit amount of Baht 37.11 million, Loss after corporate income tax for the period amount of Baht 7.30 million, Earning per share was the number of baht (0.0159) EBITDA was the amount of Baht (0.21) million. Unappropriated retained earnings amount of Baht 41.71 million.

The period the three months from April 1, 2022, to June 30, 2022, the Company's gross profit amount of Baht 15.78 million, Loss after corporate income tax for the period amount of Baht 7.09 million, and Earned per share was the number of Baht (0.0154) EBITDA was the amount of Baht (3.84) million. Unappropriated retained losses amount of Baht (18.59) million.

From a decrease in current asset amount of Baht 49.00 million by Construction contract-unbilled decreased amount of Baht 24.09 million, Cash and cash equivalents amount of Baht 32.02 million, Inventories decreased amount of Baht 6.47 million and increased of Trade-account receivable amount of Baht 18.91 million, Short-term loan increased amount of Baht 32.50 million, Non-current assets increased amount of Baht 4.70 million, impact from Plant, property, and equipment also increased from non-current contract assets and deferred tax assets too.
