Consolidated financial statements

The Company and its subsidiaries had revenue from sales of the second quarter of 2022 in the amount of 493.73 million baht, compared to the year 2021, an increase of 82.35 million baht or 20.02 percent. The change in main income came from T S Flour Mill Public Company Limited (a subsidiary) had sales revenue increased by 98.11 million baht, the company had revenue from sales of commercial buildings and townhouses decreased by 3.50 million baht and T S Oil Industry Co., Ltd. (a subsidiary) had sales revenue decrease by 11.23 million baht.

Revenue from rental and services for the second quarter of 2022 amounted to 113.54 million baht, compared to the year 2021 for the same period increased by 3.12 million baht or 2.83 percent. The main income change from the Company. Revenue from unloading and service fees increased by 1 1 .5 8 million baht, T S Warehouse Co., Ltd. (a subsidiary) had revenue from storage fees increased by 2.48 million baht, and T S Transport and Logistics Co., Ltd. (a subsidiary) which had a net revenue of the terminal decreased by 11.09 million baht.



Cost of sales in the second quarter of 2022 amounted to 420.36 million baht, compared to 2021 in the same period, an increase of 87.80 million baht or an increase of 26.40 percent.

Cost of renting and services in the second quarter of 2022 amounted to 64.71 million baht, compared to 2021 in the same period increased by 1.27 million baht or 2 percent.

Summary of consolidated financial statements in the second quarter of 2022

The company had a net profit of 45.26 million baht compared to the year 2021. During the same period, the company had a net profit of 39.53 million baht. The company's net profit increased by 5.73 million baht or an increase of 14.50 percent.

Mainly factors are as follows:

1. In the second quarter of 2022, T S Flour Mill Public Company Limited (a subsidiary) recorded gain on

 $derivatives\ contracts\ in\ the\ amount\ of\ 15.64\ million\ baht\ from\ importing\ wheat\ raw\ materials\ from\ abroad.$

2. In the second quarter of 2022, the Company's volume of incoming goods was 144,983.27 metric tons,

compared to the second quarter of 2021, an increase of 55,262.69 metric tons or 61.59 percent, and the volume of

 $exported\ goods\ was\ 131,\!101.27\ metric\ tons\ compared\ to\ Q2\ 2021,\ an\ increase\ of\ 16,\!426.71\ metric\ tons\ or\ 14.32\ percent$

3. T S Transport and Logistics Co., Ltd. (a subsidiary) had a decrease in container terminal revenue by 11.09

million baht.

As of June 30, 2022, the Company had total assets of 5,985.75 million baht, total liabilities of 2,016.66 million baht, and shareholders' equity of 3,969.09 million baht, with a debt to equity ratio (D/E ratio) of 0.51. Interest to Equity (Interest-Bearing D/E Ratio) is 0.26
