- 7) Opinion of the Board of Director: Deemed appropriate to approve the entry into such transactions since it is general issuance and offering through the Private Placement to Institutional and High Net-worth Investors (PP-II&HNW). I.C.C. International PCL obtained the debentures at an appropriate interest rate based on the Thai Bond Market Association and the same interest rate as the other debenture buyers.
- 8) Opinions of the Audit Committee and/or company director (s) which significantly different from the Board of Directors: -None-
- 9) Transaction Size: The Transaction as stated above would be within scope of the Connected Transaction of the Listed Companies according to the Notification of the Capital Market Commission Re: Rules on Connected Transactions regarding the receipt of financial assistance. A total value is THB 8.10 million or 0.23% of the Net Tangible Asset (NTA) which is greater than 0.03% but less than 3% of the Net Tangible Asset (as of the date of June 31, 2022: 0.03% of NTA = THB 1.04 million and 3% of NTA = THB 103.63 million. The Company has no other connected transactions with I.C.C. International PCL during the past six months before the date of this transaction. Therefore, the transaction is considered as a medium transaction which must be approved by the Board of Directors and disclose information to the Stock Exchange of Thailand without having to seek approval from the shareholders' meeting.
