**Revenues** For quarter 3/2022, The Company and its subsidiaries' total revenue were Baht 262.91 million, increased by Baht 76.45 million or equivalent to 41.00%, compared with the same period of the previous year. The primary cause is the increased revenues from transportation services, the major revenues comprising:

For quarter 3/2022, the company and its subsidiary revenues from transportation service, assets rental, driver behavior monitoring service, and chemicals product sales were Baht 258.25 million, comprising:

- Revenues from transportation service which is the company's major income were Baht 174.31 million or 66.30% of total revenue. Increasing from the same period of the previous year by Baht 43.00 million or equivalent to 32.74% owing to the company gaining new domestic and foreign customers, while some contracts of former customers expired.
- Revenues from assets rental and driver behavior monitoring services were Baht 18.32 million, equivalent to 6.97% of total revenue, Increasing from the same period of the previous year by Baht 6.57 million or equivalent to 55.94%
- Revenues from sales were Baht 65.62 million equivalent to 24.96 of total revenue, increasing from the previous year by Baht 26.00 million or increased by 65.62%. Owing to the increasing orders.

**Total cost** For quarter 3/2022, The Company and its subsidiaries' total cost were Baht 181.38 million, or equivalent to 68.99% of total revenue. Increasing from the same period of the previous year by Baht 53.36 million or increased by 41.68%.

The total cost is divided into two parts: cost of service and cost of sales. The increased cost of service was related to the increasing services from new contracts comprised with the higher oil price than the previous year. Also, the increased cost of sales related to the increased sales comprise with the increased cost of goods during the quarter.

Gross profit For Quarter of 3/2022, The Company and its subsidiaries' gross profit were Baht 76.87 million in total, or equivalent to 29.24% of total revenue. Increasing from the same period of the previous year by Baht 22.20 million or increasing equivalent to 40.62%. Owing to the company's and its subsidiary's increasing revenue despite the increase in overall costs, but still less than the increased income.

<u>Selling and Administrative expenses</u> The Company and its subsidiaries' selling and administrative expenses for quarter 3 of 2022 were Baht 40.85 million, decreasing from the previous year by Baht 1.85 million or decreasing equivalent to 4.32%. Because in the same period of the previous year, there were extra expenses from employee termination. As a result of the expiration of one customer's transportation contract.

Interests & Income Tax expenses The Company and its subsidiaries' interests and corporate income tax expenses for quarter 3/2022 were Baht 8.18 million or equivalent to 3.11% of total revenue, which increasing from the previous year by Baht 3.99 million or increased by 95.13%. Owing to the increase in the Company and its subsidiary profit.

**Net profit** The Company and its subsidiaries' net profit for quarter 3 of 2022 were Baht 32.49 million or equivalent to 12.36% of total revenue, which increasing from the same period of the previous year by Baht 20.94 million or increasing equivalent to 181.33%.
